MINIMUM CHARGE. FOR DOMESTIC, CANADIAN, OR FOREIGN SHIPMENTS Minimum charge is \$25.00 U.S.D. Shipments to all foreign countries must be prepaid by a letter of credit or U.S. cashier's check.

DELIVERY

All standard items listed in our catalog are regularly stocked. Shipments can be made on the same working day or the day after the order is received. Normal shipment is UPS, overnight, truck, etc. Specific delivery methods are available upon customer's request. All other, export and overseas shipments will be routed best way at our discretion.

The purchaser must register complaints with the transport carrier if delay in transport, loss,

discrepancy in weight or quantity in transit etc. occurs.

FREIGHT CHARGES

All shipments are F.O.B. Westminster MD. Freight charges are invoiced at actual cost Parcel Post and UPS shipments will be insured, according to value at our discretion. If you choose to not insure a package, once the package is with the carrier, the invoice amount is 100% your responsibility if lost.

TERMS OF SALE

Net 30 to domestic businesses with approved credit ratings. To all others, MasterCard, Visa, American Express and C.O.D. will be accepted until proper credit ratings have been established.

All past due accounts subject to a 2% per month service charge or 24% per annum. All export & overseas accounts must be paid by a letter of credit or an U.S. cashier's check.

PROPERTY OF GOODS SOLD

Any and all parts sold and delivered to a company, remain the property of SCOTTISH IMPORTS LTD, T/A British Metrics until paid in full.

Invoices at 45 days will cause your account to be locked and possible terms changed.

Invoices over 90 days will be sent for collections.

RETURNS

Any return due to our error will receive credit in full, we will supply UPS numbers upon approval of return. All other returns are subject to a minimum of 25% restocking charge within the return period. Damaged or used product will not be accepted and we will charge back shipping fees.

No returns will be accepted without a return authorization number. All returns must be sent back to us

via UPS or as instructed.

No returns will be accepted on modified or custom parts.

No returns will be accepted after 30-days of parts received.

ALL RETURNS are credited for in house credit only for 1 year and must be used or lost. NO checks will be issued.

On the return merchandise from a foreign country, including Canada, we will not be responsible for any brokerage and duties, which may be incurred regardless of the reason for the return.

BACKORDERS

All items temporarily out of stock will be back ordered, the balance of your order will be shipped the same day we receive your parts.

Cancellation of backorders are subject to penalty charges. Charges are depending on the progress of the order.

Custom made parts are cannot be cancelled or returned.
